- **Administration** – The contracting officer or specialist customizes the evaluation forms with RFP and source selection information.
- **Evaluation** – The evaluation team captures findings, including proposal strengths and weaknesses, as well as assigns ratings and risk assessments.
- **Past performance** – The evaluation team documents relevancy, quality, and other past performance.
- **Consensus** – The evaluation team reviews individual assessments and consolidates evaluation data to reach a consensus.
